



4. Functional diagram






Dual 4-input NOR gate



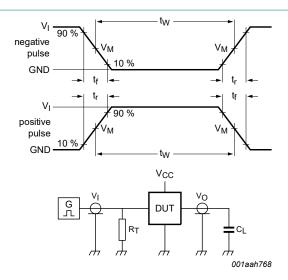

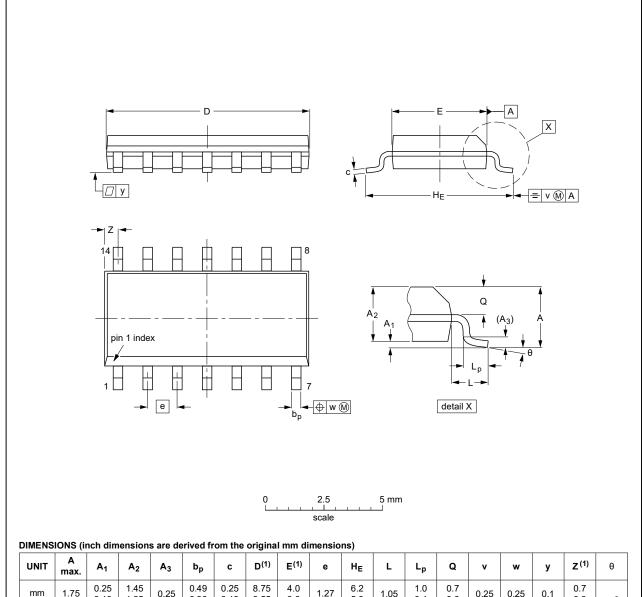

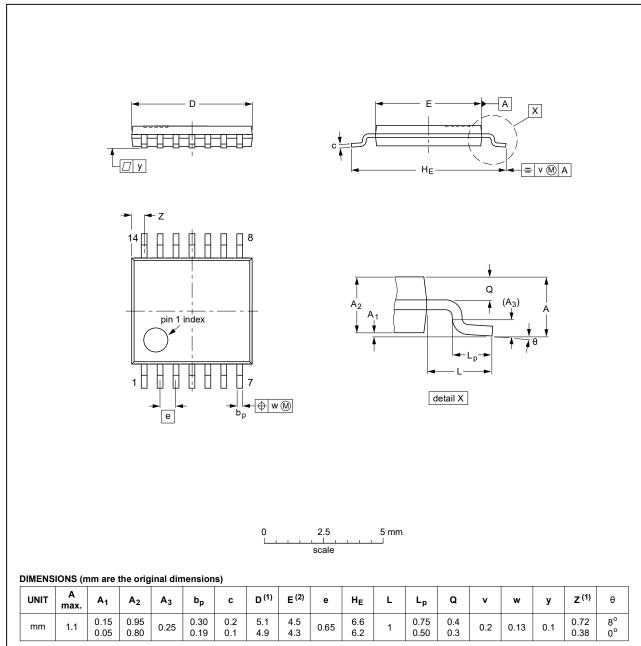
